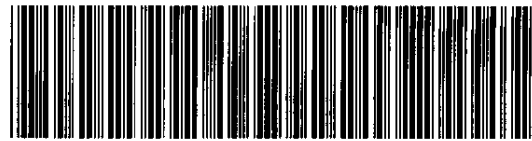

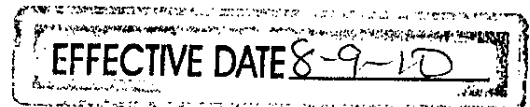

ARTICLE III COMMENCEMENT OF CORPORATE EXISTENCE

The following individual will be the initial director of the corporation:


