
ARTICLE VII - INDEMNIFICATION

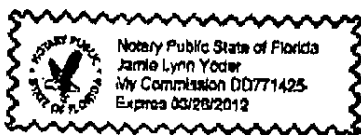


