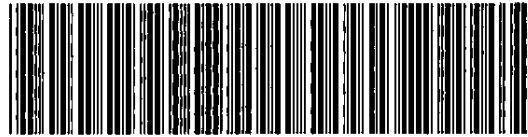

### Article I      Name

The name of the corporation is Capital City Companies, Inc.

### Article II      Address

The street address of the initial principal office and mailing address of the corporation is:

### Article III      Purpose

The corporation is formed to engage in every phase and aspect of hair grooming, sale of shampoo and hair supplies, building & repair and any other area to provide a full range of services. The manner and form, as well as the relevant terms, conditions, and details of the disposition, shall be determined by the stockholders of the corporation; provided, however, that such regulatory or restrictive provisions shall not affect the rights of third parties without actual notice of the provisions unless the existence of the provisions are plainly noted on the certificate evidencing the ownership of such stock. No stockholder of the corporation may sell or transfer stock in the corporation except to another individual, professional corporation, or professional limited liability company who is eligible to be a stockholder of the corporation, unless the sale or transfer has been approved at a stockholder meeting especially called for that purpose.

**Article X Indemnification**

The corporation shall indemnify its directors, officers, employees, and agents to the full extent permitted by law.

**Article XI Amendment**

These articles of incorporation may be amended, altered, or changed at any time, and from time to time, in the manner now or hereafter prescribed by the applicable Florida Statutes, and all rights conferred on a stockholder herein are granted subject to this reservation.

**Article XII Effective Date**

The existence of the corporation shall commence at 12:01 a.m. on August 16, 2010.


