ARTICLES OF INCORPORATION
OF
THE ELLZEY GROUP, INC.

The undersigned, acting as incorporator of this Corporation pursuant to Chapter 607 of the Florida Statutes, hereby forms a corporation for profit under the laws of the State of Florida and adopts the following Articles of Incorporation for such Corporation:

ARTICLE I - NAME OF CORPORATION

The name of this Corporation shall be The Ellzey Group, Inc.

ARTICLE II - PRINCIPAL OFFICE AND MAILING ADDRESS

The principal office of this Corporation shall be located at 1211 Semoran Blvd., Suite 297, Casselberry, Florida 32707. The mailing address of the Corporation shall be 125 Oxford Road, Casselberry, Florida 32730.

ARTICLE III - CAPITAL STOCK

The maximum number of shares of capital stock that this Corporation is authorized to issue and have outstanding at any one time is ten thousand (10,000) shares of common stock having a par value of One Dollar (\$1.00) per share.

**ARTICLE IV - INITIAL REGISTERED OFFICE
AND REGISTERED AGENT**


ARTICLE VIII - INDEMNIFICATION

ARTICLE IX - DATE OF EXISTENCE


This Corporation shall exist perpetually, commencing on the date of filing of these Articles of Incorporation.
