#### **ARTICLE I - NAME**

The name of the corporation is Techsters, Inc., at 277 Malabar Road, Palm Bay, FL 32907 (Principal Office of Registered Agent).

#### **ARTICLE II - DURATION**

This corporation shall exist perpetually, commencing at the time of filing these articles with the Secretary of State of the State of Florida.

#### ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any of all lawful business.
