The undersigned, acting as incorporator of Harbor Holdings, Inc., under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

ARTICLE III. COMMENCEMENT OF EXISTENCE

The existence of the corporation will commence at 12:01 A.M., the date of filing of these Articles of Incorporation.

ARTICLE V. AUTHORIZED SHARES


ARTICLE IX. BYLAWS
