ARTICLES OF INCORPORATION

OF

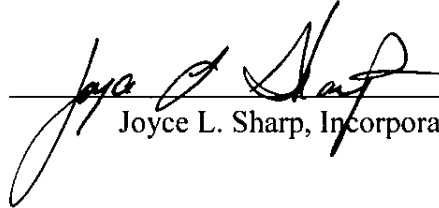
**ARTICLE X

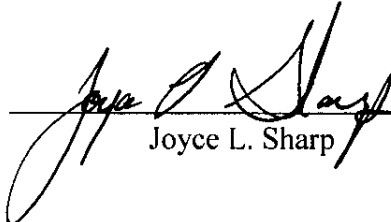
