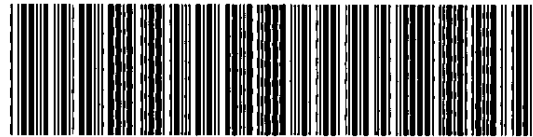

**ARTICLES OF INCORPORATION
OF**

The undersigned, for the purpose of becoming incorporated and forming a corporation under and by virtue of the laws of the State of Florida, certify as follows:

ARTICLE 1.

The name of this corporation shall be:

Decorator Training Institute, Inc.

ARTICLE II.

The principal place of business and the mailing address of the corporation:

The general nature of the business or businesses to be transacted under these Articles of Incorporation shall be: To provide certification training programs for interior decorators. To carry on any business or to engage in any activity which is permitted under the laws of the United States and of the State of Florida.

The maximum number of shares of stock which this corporation is authorized to have outstanding at any one time shall be 100 shares of common stock of a value of Five Dollars per share, each to be exempt from assessment.

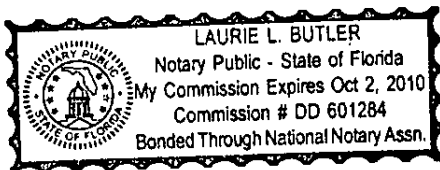
