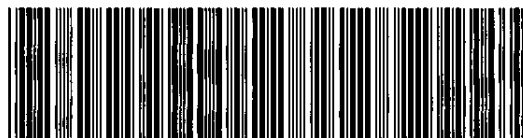

SECOND: The company's articles of incorporation were filed on August 25, 2010.

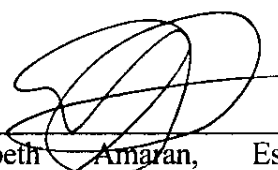
THIRD: The Corporation has not commenced business and none of the Corporation's shares of stock have been issued.
