We, the undersigned, Catherine W. Foulks, and Vera L. Willis of 14882 Old Thicket Trace, Winter Garden, Florida 34787 respectively being at least eighteen (18) years of age, do hereby form a corporation under the general laws of the State of Florida.

ARTICLE I

The name of the Corporation which is hereinafter called the Corporation is ABC Academy and Education Services, Inc.

ARTICLE II

The provisions limiting or denying to shareholders the pre-emptive right to acquire additional shares of the Corporation shall be set by a majority of the Board of Directors.


ARTICLE VII

The provisions of the regulations of the internal affairs of the Corporation are subject to the code and laws of the state of Florida and the Corporate by-laws.


ARTICLE VIII
