ARTICLES OF AMENDMENT OF THE ARTICLES OF INCORPORATION OF HIALEAH AUTO TAG AGENCY, INC..

- 1. The name of the corporation is HIALEAH AUTO TAG AGENCY, INC. (the "Corporation").
