The name of this corporation is T & L CONSTRUCTION, INC., located at 484 Morning Glory Drive, Lake Mary, Florida, 32746.

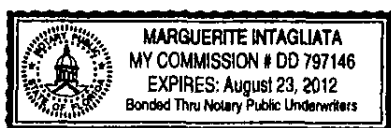




