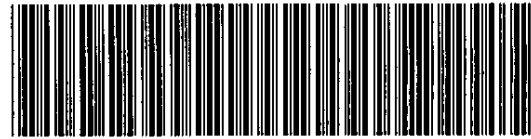

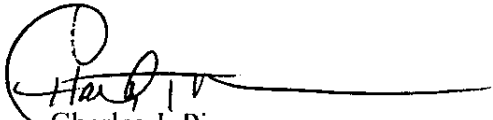

ARTICLE I

Name of Corporation

The name of this corporation is J & Z INVESTIGATION AND PROTECTION SERVICES INC.

ARTICLE II

Purpose

J & Z INVESTIGATION AND PROTECTION SERVICES INC. is organized to provide investigation and protection service. With the approval of its Board, the company may transact in any and all other lawful businesses permitted under the laws of the United States and the State of Florida.

ARTICLE III

Capital Stock

Initially, this Corporation is authorized to issue 10,000 shares of common stock at \$0.01 dollar par value.

ARTICLE IV

Corporate existence

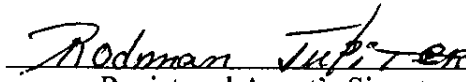

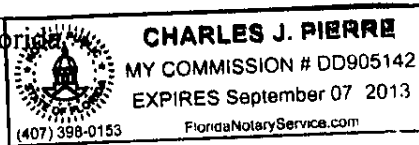
