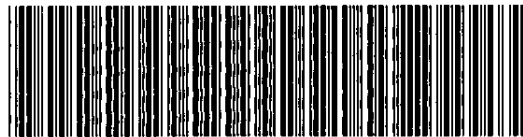

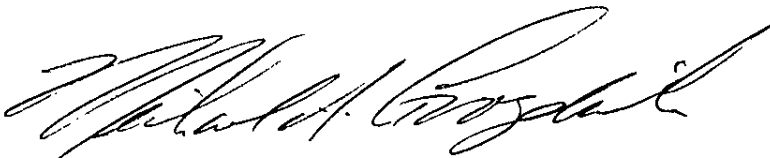

ARTICLES OF INCORPORATION  
OF  
CLINTREX SERVICES, INC.

ARTICLE 1-NAME

The name of this Corporation is Clintrex Services, Inc.

ARTICLE II-NATURE OF BUSINESS

The Corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE III-CAPITAL STOCK

The authorized capital of the Corporation shall be 100,000 shares of the common stock at a par value of \$0.01 per share.

ARTICLE IV-TERM OF EXISTENCE

This Corporation is to exist perpetually.

ARTICLE V-PREEMPTIVE RIGHTS

Every stockholder, upon the sale for cash of any new stock of this Corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE VI-PRINCIPAL OFFICE AND MAILING ADDRESS

This Corporation shall have one director initially. The directors are to be elected and the number of directors may be increased or diminished from time to time, as provided in the bylaws adopted by the stockholders, but shall never have less than one nor more than twelve.

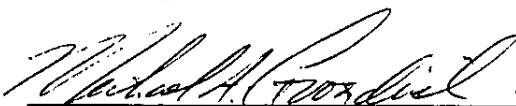

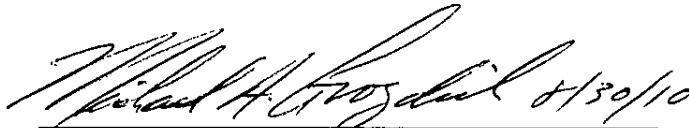
