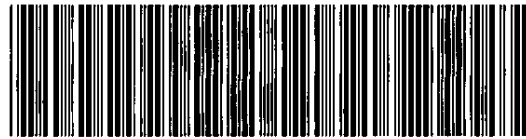

ARTICLE XII AMENDMENTS OF ARTICLES

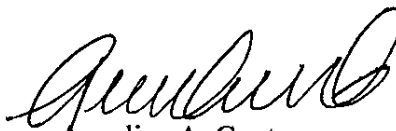

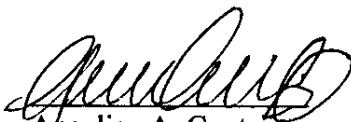
