ARTICLES OF INCORPORATION
OF
STILLCRAZY CROSSFIT, INC.

THE UNDERSIGNED, acting as sole incorporator of a corporation to be formed under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

FIRST: The name of the corporation (the "Corporation") is STILLCRAZY CROSSFIT, INC.

SECOND: The initial principal office and mailing address of the Corporation is StillCrazy Crossfit, Inc., 829 Palm View Drive, Naples, FL 34110-1241.

THIRD: The purpose of the Corporation is to conduct the business of a fitness training facility/gym, and to do such other things and take such other actions as may be necessary and permissible for a corporation found under the Act.

FOURTH: The aggregate number of shares that the Corporation is authorized to issue is Seven Thousand Five Hundred (7,500) shares of common stock and the par value of each share shall be one dollar (\$1.00). Par value shall have no effect on the Corporation's capital structure.

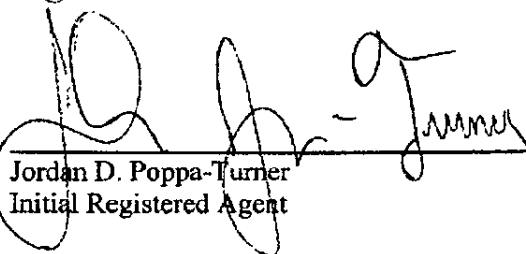
