# ARTICLES OF INCORPORATION OF LA LEY SECURITY & PROTECTION, INC., a Florida Corporation

The undersigned hereby submits these Articles for the purpose of becoming a corporation under the laws of the State of Florida, by end under the provisions of the Statutes of the State of Florida, providing for the formation, liabilities, rights, privileges and immunities of a corporation for profit.

### **ARTICLE I**

The name of this corporation shall be:

merchandise, articles, materials and equipment of all kinds and as act as a mortgage brokerage firm and/or business.

SECTION 4. To manufacture, purchase, or otherwise acquire, and to own, mortgage, pladge, assign, sell, transfer, otherwise dispose of, and to invent in, trade in, deal in and with goods, wares, merchandise, real and personal property, and services of every class, kind and description, except that it not to conduct a banking, safe deposit, trust, insurance, surety, express reliroad, canal, telegraph, telephone or carnetery company, a building and loan association, mutual fire insurance association, cooperative association, fratemal benefit society, state fair or exposition.

<u>SECTION 5.</u> To conduct business in, have one or more offices in, and buy, hold, mortgage, sell, convey, lease or otherwise dispose of real and personal property, including franchises, patents, copyrights, trademarks, and licenses in the State of Florida and in all other states and countries.
