ARTICLES OF INCORPORATION

OF

FUTURE GENERATIONS SCIENCE & TECHNOLOGY CTR., INC.

ARTICLE I - NAME

The name of the corporation is Future Generations Science & Technology Ctr., Inc., at 751 Niagara Street NW, Palm Bay, FL 32907 (Principal Office of Registered Agent).

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing at the time of filing these articles with the Secretary of State of the State of Florida.

ARTICLE III - PURPOSE
