The undersigned incorporator hereby files these Articles of Incorporation in order to form a corporation under the laws of the State of Florida.

ARTICLE I

Name and Principal Office of Corporation

The name of this Corporation shall be AVELLINO PROPERTIES, INC. The initial mailing address of the Corporation shall be 199 Ocean Lane Drive, No. 914, Key Biscayne, Florida 33149.

Purpose and Nature of Business


