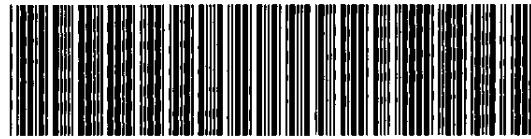

The Undersigned do hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

**ARTICLE I. - NAME AND ADDRESS**

**ARTICLE II - PURPOSE**

## **ARTICLE XV – PRIVATE PROPERTY OF SHAREHOLDERS**

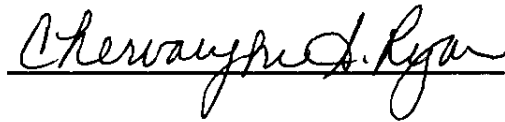

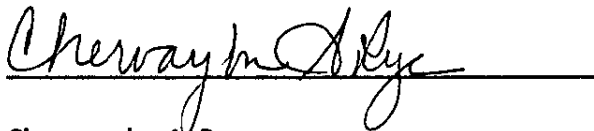
