ARTICLES OF INCORPORATION:

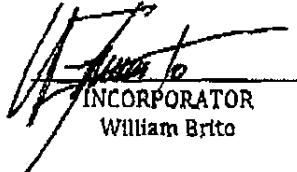

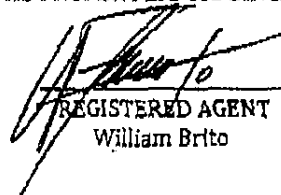
