ARTICLES OF INCORPORATION

OF

The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby form a corporation for profit under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation is FAST AND EASY TRANSPORT, INC.
