

#### ARTICLE 1 - NAME

The name of the Corporation is **JARVIS SOLUTIONS INC.**, (hereinafter, "Corporation").

#### ARTICLE 2 - PURPOSE OF CORPORATION

# ARTICLE 7 - CORPORATE CAPITALIZATION

- 7.1 The maximum number of shares that this Corporation is authori have outstanding at any time is TEN THOUSAND (10,000) shares of common each share having the par value of ONE CENT (\$.01).
- 7.2 All holders of shares of common stock shall be identical with each in every respect and the holders of common shares shall be entitled to have unlyoting rights on all shares and be entitled to one vote for each share on all m on which Shareholders have the right to vote.
- 7.3 All holders of shares of common stock, upon the dissolution (Corporation, shall be entitled to receive the net assets of the Corporation.
- 7.4 No holder of shares of stock of any class shall have any preemptive to subscribe to or purchase any additional shares of any class, or any bor convertible securities of any nature; provided, however, that the Board of Directory, in authorizing the issuance of shares of stock of any class, conferentiate right that the Board of Director(s) may deem advisable in connection such issuance.

#### ARTICLE 8 - SUB-CHAPTER S CORPORATION

The Corporation may elect to be an S Corporation, as provided in Sub-Chapter S of the Internal Revenue Code of 1986, as amended.

- 8.1 The shareholders of this Corporation may elect and, if elected, shall continue such election to be an S Corporation as provided in Sub-Chapter S of the Internal Revenue Code of 1986, as amended, unless the shareholders of the Corporation unanimously agree otherwise in writing.
- 8.2 After this Corporation has elected to be an S Corporation, none of the shareholders of this Corporation, without the written consent of all the shareholders of this Corporation shall take any action, or make any transfer or other disposition of the shareholders' shares of stock in the Corporation, which will result in the termination or revocation of such election to be an S Corporation, as provided in Subchapter S of the Internal Revenue Code of 1986, as amended.
- 8.3 Once the Corporation has elected to be an S Corporation, each share of stock issued by this Corporation shall contain the following legend:

"The shares of stock represented by this certificate cannot be transferred if such transfer would void the election of the Corporation to be taxed under Sub-Chapter S of the Internal Revenue Code of 1986, as amended."

#### ARTICLE 9 - SHAREHOLDERS' RESTRICTIVE AGREEMENT

All of the shares of stock of this Corporation may be subject to a Shareholders' Restrictive Agreement containing numerous restrictions on the rights of shareholders of the Corporation and transferability of the shares of stock of the Corporation. A copy of the Shareholders' Restrictive Agreement, if any, is on file at the principal office of the Corporation.


#### ARTICLE 10 - POWERS OF CORPORATION
