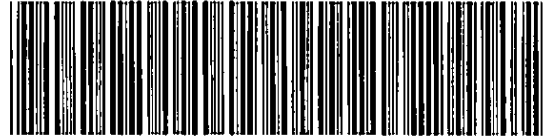


The shareholder interest statement indicates that Anthony Savarese Jr., owns 49% of the corporation and
