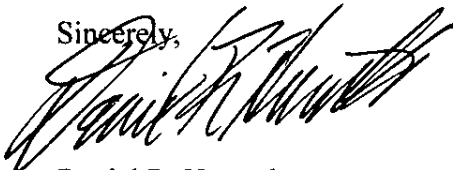

The undersigned, acting as incorporator of a corporation under Florida Statutes hereby adopts the following Articles of Incorporation for said corporation.

ARTICLE I - NAME: The name of the corporation shall be: **SOULS TO THE POLLS, INC.**

ARTICLE II - PRINCIPAL OFFICE: The principal place of business and mailing address is: LuTimothy May; 1000 North "L" Street; Pensacola, Florida 32501.

ARTICLE III - PURPOSE: The purposes for which the corporation is organized are: to provide a wide variety of services including, but not limited to: providing general education and assistance in registering to vote; understanding the importance of voting; providing transportation assistance for voting purposes for those needing such services; and other activities related to the voting process and participation therein.

ARTICLE IV - SHARES: The number of shares of stock is one thousand (1,000) shares of common stock with a par value of Fifth Dollars (\$50.00) per share.

ARTICLE V - INITIAL OFFICERS AND/OR DIRECTORS: The President and sole director of the corporation shall be LuTimothy May at 1000 North "L" Street; Pensacola, Florida 32501.

ARTICLE VI - REGISTERED AGENT: The name and Florida street address of the registered agent is: LuTimothy May at 1000 North "L" Street; Pensacola, Florida 32501.

ARTICLE VII - INCORPORATOR: The name and address of the incorporator is: LuTimothy May at 1000 North "L" Street; Pensacola, Florida 32501.

ARTICLE VIII - AMENDMENTS: These Articles of Incorporation may be amended by the board of directors adopting a resolution setting forth the proposed amendment. The proposed amendment must then be ratified by a majority vote at a meeting of the shareholders that was properly called and held in Florida in accordance with the provisions of the Bylaws of the corporation.

ARTICLE IX - REMOVAL OF DIRECTORS: Any director or the entire board of directors may be removed by the shareholders, with or without cause, at a special shareholder meeting called expressly for that purpose in accordance with the requirements for such a meeting as is specified in the Bylaws. The method of electing directors shall be as stated in the Bylaws of the corporation.

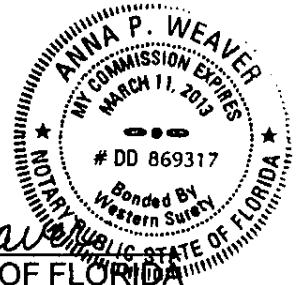
