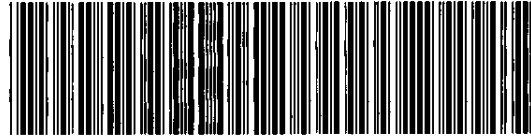

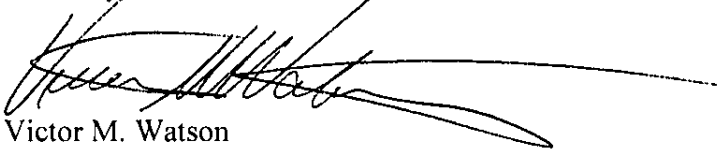

**ARTICLES OF INCORPORATION  
OF**

**Article XII - Amendment**

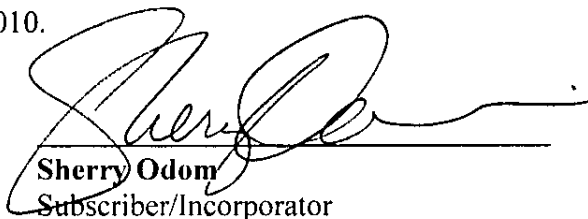
