ARTICLES OF INCORPORATION

OF

CARE OF COMFORT ADULT FAMILY CARE HOME, INC.

FILED SECRETARY G STATE FALLAHASSEE FLORIDA

ARTICLE I - NAME

The name of the corporation is Care of Comfort Adult Family Care Home, Inc., at 502 Fellenz Street SW, Palm Bay, FL 32908 (Principal Office of Registered Agent).

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing at the time of filing these articles with the Secretary of State of the State of Florida.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any of all lawful business.
