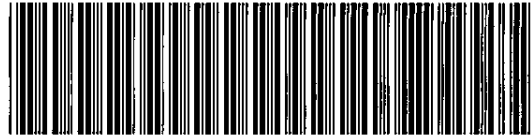

ARTICLE III-CAPITAL STOCK



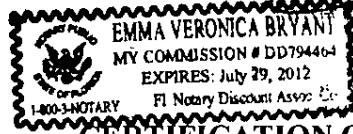
