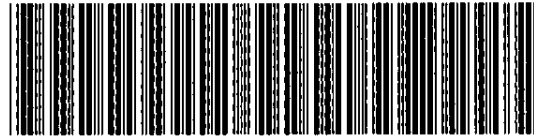

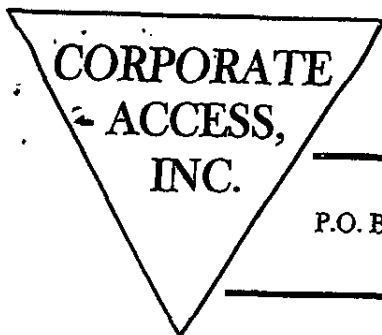

NAME

The name of this corporation is Clarke Home Products, Inc.

ARTICLE II.

PRINCIPAL OFFICE

DURATION; EFFECTIVE DATE
