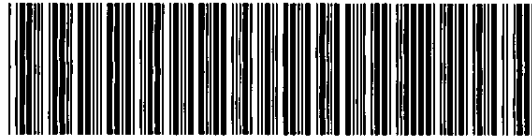

**ARTICLES OF INCORPORATION
OF
TROUBLED ASSETS MANAGEMENT CORPORATION**

In compliance with the requirements of F.S. Chapter 607 and 621, the undersigned hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation is: Troubled Assets Management Corporation.

ARTICLE II

The existence of the Corporation shall begin on the date of filing of these Articles of Incorporation.

ARTICLE III

The street address of the principal office and mailing address of the Corporation is 259 East 7th Avenue, Tallahassee, FL 32303.

ARTICLE IV

The specific purpose for which the Corporation is organized is to conduct any lawful business allowed by the Florida Statutes..

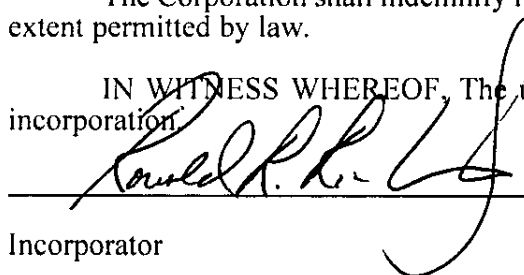

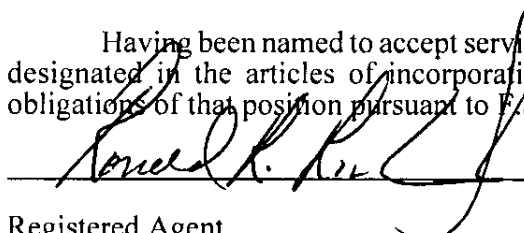
