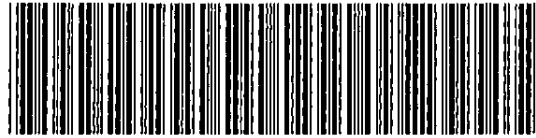

The undersigned subscriber to these Articles of Incorporation hereby forms a corporation under the Florida General Corporation Act.

**ARTICLE I - NAME**

The name of this corporation is **MONDO GOURMET COFFEE & MARKET, INC.**

The corporation shall have a perpetual existence.

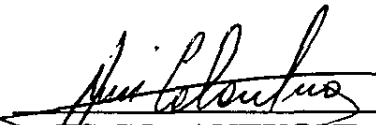

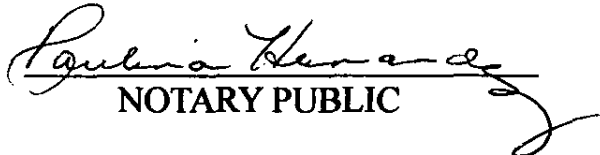
