**ARTICLES OF INCORPORATION
OF
CENTRAL BARK 'N BREW, INC.**

THE UNDERSIGNED, acting as sole incorporator of **CENTRAL BARK 'N BREW, INC.**, under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

**ARTICLE I.
NAME**

The name of the corporation is **CENTRAL BARK 'N BREW, INC.**

**ARTICLE II.
SHARES**

The authorized capital stock of the Corporation shall consist of 1,000 shares of common stock, no par value. Each share of the Corporation's common stock shall have the same rights and preferences as each other share of the Corporation's common stock.


