ARTICLES OF INCORPORATION OF LUNCIE INC.

ARTICLE I: NAME

NAME The name of the corporation is **Luncie Inc.**

ARTICLE II: PURPOSE

The purpose of the corporation is to engage in any lawful act or activity for which a corporation may be organized under incorporation provisions of the Florida Statutes other than the banking business, or the practice of a profession.

ARTICLE VII: REGISTERED AGENT

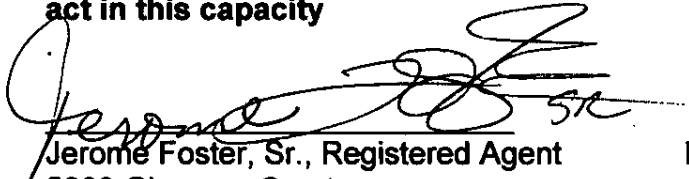

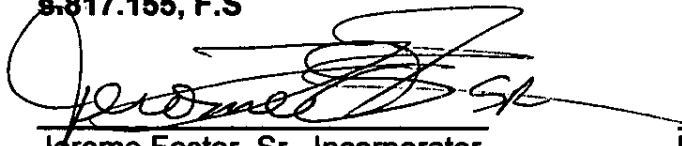
