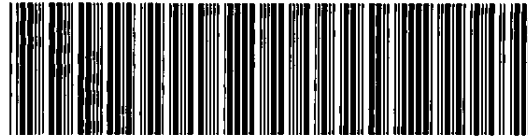

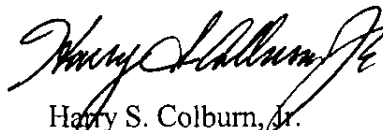

The undersigned, acting as incorporator of a corporation under the Florida Statutes, adopts the following Articles of Incorporation:

Article I - Name

The name of this corporation is Wolfe - Co.

Article II - Duration

This corporation shall have perpetual duration commencing on the date of execution of these Articles of Incorporation.

Article III - Purpose

The general purpose or purposes for which the corporation is organized are to engage in any and all lawful business.

Article IV - Capital Stock

The aggregate number of shares which the corporation shall have authority to issue is 10,000 shares, and the par value of each such share is One Dollar (\$1.00). All such shares are of one class and are designated as common stock.

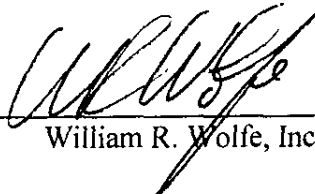
Article IX - By-Laws

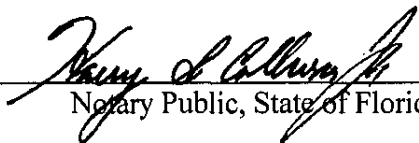

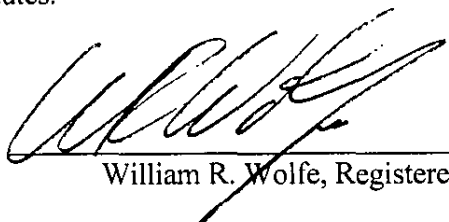
