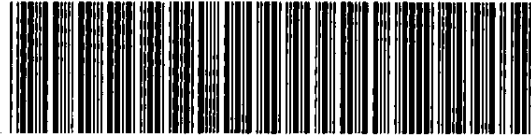

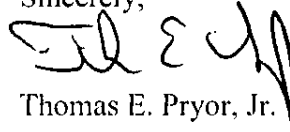

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE 1-NAME

The name of the corporation shall be CTAB, INC.

ARTICLE 2-PRINCIPAL OFFICE

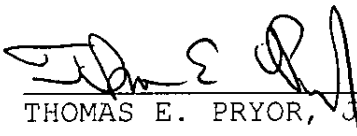

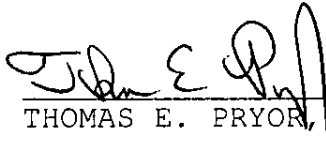
