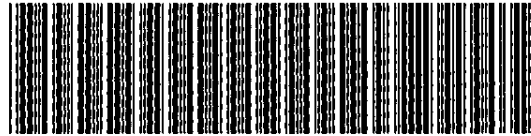

The undersigned subscriber to these Articles of Incorporation, a natural person, being of legal age and competent to contract, hereby forms a corporation pursuant to the laws of the State of Florida, hereby adopts the following Articles of Incorporation, and hereby agrees and certifies as follows:

ARTICLE I
NAME

The name of the Corporation shall be DEBBIE DAWSON, P.A., A FLORIDA PROFESSIONAL ASSOCIATION.

ARTICLE II
COMMENCEMENT OF CORPORATE EXISTENCE

This Corporation (the "Corporation") shall commence corporate existence immediately upon the filing of these Articles with the Florida Secretary of State and shall have perpetual existence unless sooner dissolved according to law.

ARTICLE III
NATURE OF BUSINESS

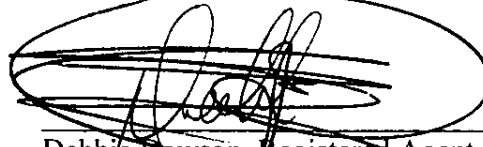
