**ARTICLES OF INCORPORATION

1. **NAME.** The name of this corporation is CV GLOBAL, INC.
2. **PURPOSE.** The purpose for which the corporation is organized is:

The transaction of any and all lawful business for which a corporation may be incorporated under the Florida General Corporation Act; except that it is not to conduct a banking, safe deposit, trust, insurance, surety, express, railroad, canal, telegraph, telephone or cemetery company or a building and loan association, mutual fire insurance association, co-operative association, fraternal benefit society, state fair or exposition.

3. **CAPITAL STOCK.** The aggregate number of shares of stock which the corporation shall have authority to issue is 1,000,000 and each share shall be of the par value of One (\$1.00) Dollar.

4. **DURATION.** The corporation shall have a perpetual existence and its existence shall commence on the date of the execution and acknowledgment of these Article of Incorporation.

5. **INITIAL REGISTERED OFFICE AND AGENT.** The street address of the initial registered office of the corporation is 1724 Manatee Avenue West, Bradenton, Florida 34205, and the name of the initial registered agent of the corporation at that address is Thomas A. Moseley. The principal business address of the corporation is 4728 Lark Ridge Circle, Sarasota, Florida 34322.

6. **NUMBER OF DIRECTORS.** The corporation shall have two (2) directors initially. The number of directors may be increased or diminished from time to time, by By-laws by the stockholders, but shall never be less than one.

Such option shall inure to the benefit of the other stockholders (who desire to accept same) pro rata.
