# **PURPOSE**

This corporation is organized for the following purposes:

1. Any and all lawful purposes, activities or business permitted under the laws of the United States and the State of Florida.

# **ARTICLE III**

# CAPITAL STOCK

The aggregate number of shares that the Corporation is authorized to issue is ten million (10,000,000) shares, divided into two (2) classes. The designation of each class, the number of shares of each class, and the par value or no par value of the shares of each class are as follows:

This corporation is authorized to issue 5,000,000 shares of common stock.

The common stock of the corporation shall have the following characteristics:

- (a) Par value shall be No Par per share.
- (b) At all meetings of the stockholders, the common stockholders shall be entitled to cast one (1) vote for each share of common stock owned. That a common stockholder is interested in a matter to be voted upon shall not disqualify him from voting thereon.
- (c) Except as otherwise provided by law, in order for common stockholders to exercise their vote, the shares which the stockholder is intending to vote must be owned and paid in full.

  This corporation is authorized to issue 5,000,000 shares of preferred stock.

The preferred stock of the corporation shall have the following characteristics

- (a) Par value shall be No Par per share.
- (b) At all meetings of the stockholders, the preferred stockholders shall be entitled to cast ten (10) votes for each share of common stock owned. That a preferred stockholder to be voted upon shall not disqualify him from voting thereon.
- (c) In the event of any voluntary or involuntary liquidation, dissolution or winding up of the affairs of the corporation, then, before any distribution or payment shall be made to the holders of the common shares, the holders of the preferred shares shall be entitled to be paid in full their capital contributions, any dividends or distributions which have been declared but remain unpaid, plus accrued dividends to such distribution payment date, whether or not earned or declared.

#### **ARTICLE IV**

#### TERM OF EXISTENCE

This corporation shall have perpetual existence commencing on the date of receipt of these Articles of Incorporation by the Secretary of State of Florida.
