**ARTICLES OF INCORPORATION  
OF  
LOTUS 9, INC.**

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation:

**ARTICLE ONE**

The name of the corporation is: **LOTUS 9, INC.**

**ARTICLE TWO**

The term of existence of the corporation is perpetual.

**ARTICLE THREE**

The purposes for which the corporation is organized are:

To engage in the business of marketing, promoting and distributing communication and entertainment products and devices of all types and nature in all parts of the world, as retailers and wholesalers and as principals and agents.

To engage in the transaction of any and all lawful business for which corporations may be incorporated under the Florida Business Corporation Act.

**ARTICLE FOUR**






