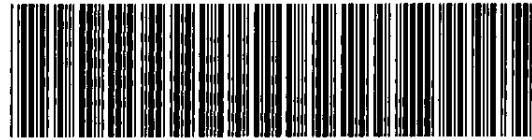

This corporation may be a sub-chapter S corporation as defined by the Internal Revenue Code.

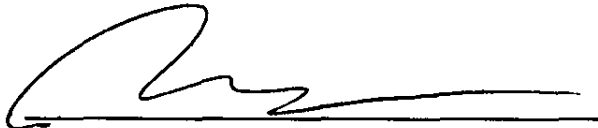

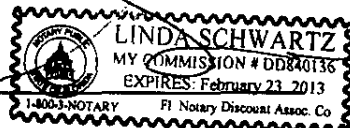
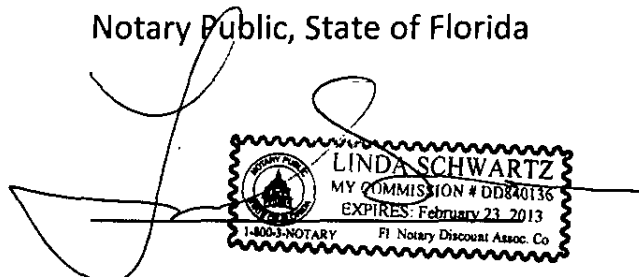
