ARTICLES OF INCORPORATION

OF

5 STAR SERVICE CENTER, INC.

ARTICLE I - NAME

The name of the corporation is 5 Star Service Center, Inc., at 4220 Dow Road, Melbourne, FL 32934 (Principal Office of Registered Agent).

ARTICLE II - DURATION
