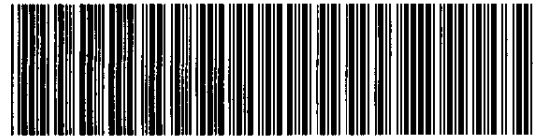

ARTICLE I. NAME

The name of this corporation is NINA PROPERTIES, INC.




