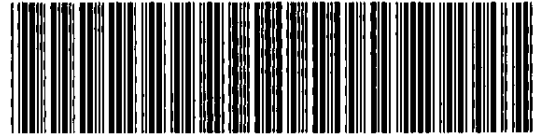




1. I am the President and sole Director of Financial Media Net, Inc., a Nevada corporation.
