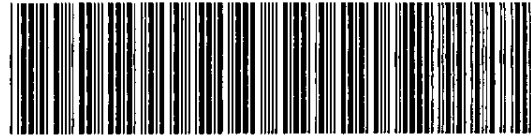


RE: Dissolution of Profit Corporation, Remember Me By Photography, Inc.
