

## For Profit ARTICLES OF INCORPORATION

### **Agape Family Education Project and Counseling Program** *Inc.*

In compliance with the requirements of Chapter 607, F.S., and for the purposes of forming a for-profit business corporation in Florida, the undersigned desire to form a corporation according to the following Articles of Incorporation.

#### **Article I- Corporate Name**

The name of the corporation is Agape Family Education Project and Counseling Program *Inc.* (the "Corporation").

#### **Article II- Purpose**

The purpose of this corporation is counseling individuals and families in crisis, educating families by providing life skills, health issues, and nutritional courses.  
Prevent prison recidivism of youth offenders and prevent gang activity through support services and substance abuse education/prevention/rehabilitation.  
Development of small businesses and other business services

#### **Article III- Duration**

The duration of the Corporation is perpetual.

#### **Article IV-Registered Office and Registered Agent**
