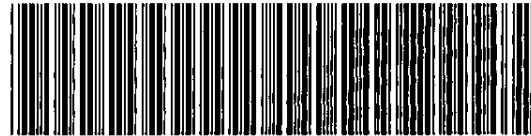

AGREEMENT AND PLAN OF MERGER

Pursuant to the provisions of the §607.1104 of the Florida Business Corporation Act (the "**FBCA**"), Excel Staffing Solutions, Inc., a Florida corporation ("**Excel Staffing**"), and Excel Recruiting Management Corporation, a Florida corporation ("**Excel Management**"), approve and submit the following Agreement and Plan of Merger (this "**Plan**") to effectuate a merger of Excel Staffing with and into Excel Management (the "**Merger**");

WHEREAS, Excel Management owns one hundred percent (100%) of the issued and outstanding capital stock of Excel Staffing; and

WHEREAS, following the Merger, Excel Management will be the surviving entity and all of the capital stock of Excel Staffing shall be cancelled, null and void; and


WHEREAS, there are no shareholders of Excel Staffing who are entitled to appraisal rights.

For consideration, the receipt and sufficiency is hereby acknowledged, Excel Staffing and Excel Management agree as follows:

1. The above recitals are incorporated into this Plan and acknowledged as being true.
2. Excel Staffing and Excel Management agree to Merge, and that Excel Management will be the surviving entity.
