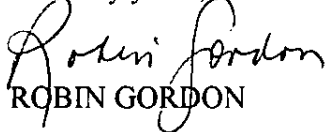

The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I. NAME & PRINCIPAL OFFICE

The name of the corporation shall be: **SWEET TOPPINGS, INC..**

ARTICLE II. NATURE OF BUSINESS
