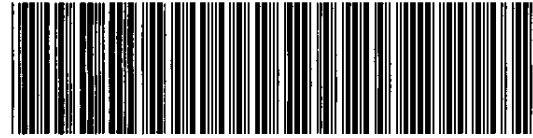



Article 1. NAME. The name of this corporation is MANIPULATE MEN, INC.




