ARTICLES OF INCORPORATION NOV 15 PM 4:

PHOENIX AUTOMOTIVE GROUP, INC.

We, the undersigned, hereby associate ourselves together for the purpose of forming a Corporation, for profit, under the general Corporation laws of the State of Florida, in accordance with the following Certificate of Incorporation:

ARTICLE I NAME

The name of the corporation shall be **PHOENIX AUTOMOTIVE GROUP, INC.**Its principal place of business shall be, 5317 Ashton Court, Sarasota, Florida 34233 in the County of Sarasota, and the State of Florida. The mailing address of the Corporation shall be the same but the Corporation shall have the power to transact business at such place or places as the Board of Directors may designate, and branch offices and places of business may be established in such places within or without the State of Florida as the Board of Directors from time to time may direct.

ARTICLE II DURATION

The term of existence of the corporation shall be perpetual, or until dissolved according to laws of the State of Florida.

ARTICLE III POWERS OF CORPORATION

This corporation shall have the power to:

- 1. To have perpetual succession by its corporate name.
- 2. To sue and be sued, complain and defend in its corporate name in all actions and proceedings.
- 3. To have a corporate seal which may be altered at pleasure, and to use the same causing it, or a facsimile thereof, to be impressed or affixed or in any other manner reproduced.
- 4. To deal in, but not limited to the manufacturing of automotive parts, the purchase and resell of automotive parts, as well as all other related services.
- 5. To purchase, take, receive, lease or otherwise acquire, own, hold, improve, use and otherwise deal in and with, real or personal property, or any interest therein, wherever situated.
- 6. To sell, convey, mortgage, pledge, create a security in, lease, exchange, transfer and otherwise dispose of all or part of its property and assets.
- 7. To lend money and use its credit to assist its officers and employees in accordance with the law
- 8. To make contracts and guarantees and incur liabilities, borrow money at such rates of interest as the corporation may determine, issue its notes, bonds and other obligations, and secure any of its obligations by mortgage or pledge of any or all of its property, franchises and income.

Whenever any share or shares of stock are issued in consideration of payment to be made in property or in services, the fair and just value of the property to be transferred or the services performed or rendered, or to be performed or rendered, as a consideration for the issuance of said stock shall be fixed by the Board of Directors of said corporation. The Corporation shall indemnify any person who was or is a party or is threatened to be made a party to any threatened, pending or completed action, suit or proceeding, whether civil or criminal, administrative or investigative, by reason of the fact that he is or was a director, officer, employee or agent of the corporation, or is or was serving at the request of the corporation as a director, officer, employee or agent of another corporation, partnership, joint venture, trust, or other enterprise, against expenses (Including attorneys' fees), judgments, fines and amounts paid in settlement, actually and reasonably incurred by him in connection with such action, suit or proceeding, including any appeals thereof, if he acted in good faith or in a manner he reasonably believed was lawful. However, with respect to any action by or in the right of the Corporation to procure a judgment in its favor, no indemnification shall be made in respect of any claim, issue or matter as to which such person is adjudged liable for

negligence or misconduct in the performance of his duty to the corporation unless, and only to the extent that, the court in which such action or suit was brought determines, on application, that despite the adjudicate of liability, such person is fairly and reasonably entitled to indemnify in view of all the circumstances of the case. Any indemnification hereunder shall be made only on a determination by a majority of disinterested directors, subject to the approval of a majority of stockholders, that indemnification is proper in the particular circumstances because the party to be indemnified has met the applicable standard of conduct. Determination of any such action, suit or proceeding by judgment order, settlement, conviction, or on a plea of nolo contender or its equivalent, shall not, of itself, create a presumption that the party did not meet the applicable standard of conduct.
