# ARTICLES OF INCORPORATION

# ARTICLE 1 - NAME

The name of the corporation is Dynasty Consultants, Inc., at 6212 Goleta Circle, Melbourne, FL 32940 (Principal Office of Registered Agent).

# **ARTICLE II - DURATION**

This corporation shall exist perpetually, commencing at the time of filing these articles with the Secretary of State of the State of Florida.

#### ARTICLE III - PURPOSE
